- During the month of October, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 7 day and 14 residential program visits.
- The SCDDO received notice in October that KETCH was going to discontinue providing targeted case management (TCM) services by the end of the year (later revised to end of January, 2022). KETCH is one of the largest providers of TCM in our service system. Immediately, SCDDO staff became concerned about the system capacity to serve the nearly 200 persons receiving TCM at KETCH and began strategizing about how to accomplish the required options counseling. A meeting with agencies that provide TCM services was held on October 20<sup>th</sup> to discuss each agency's capacity to accept new referrals and whether capacity could be stretched to meet this challenge. The Sedgwick County provider network understood the issue and agreed to work with the SCDDO to ensure individuals continue to receive TCM services. Heather Pace, SCDDO Service Access Manager is providing regular reports on what agencies are being chosen to allow SCDDO management and TCM agencies to monitor and adjust to meet the capacity demands. Heather and her staff are also providing assertive outreach to individuals impacted by KETCH's decision, including going out to day programs to offer onsite options counseling.
- October was the kick off for SCDDO planning efforts for its next strategic plan (2022 through 2025). On October 5<sup>th</sup> the SCDDO management team met at the zoo for a retreat. This meeting focused primarily on clarifying our current reality and looking for gaps and opportunities. No decisions were made at this meeting, it just served to start the strategic thinking process. All SCDDO staff convened October 11<sup>th</sup> to participate in strategic planning. At least one additional meeting with SCDDO staff is planned and a survey has been widely distributed to gather stakeholder input.

- In October the Project SEARCH interns participated in mock interviews and resume reviews. Human Resource
  professionals volunteered to conduct these mock interview and provide feedback to build the interns'
  interviewing skills. Interns from all the Project SEARCH sites in Sedgwick County participated, including Wichita
  Public Schools (Sedgwick County and Via Christi sites), Derby Public Schools, Maize Public Schools and the adult
  Project SEARCH program through Goodwill.
- The Sedgwick County Developmental Disability Community Council met October 29<sup>th</sup>. LaTonia Wright with the Kansas Department on Aging & Disability Services gave a presentation on Kansas' efforts to come into compliance with the federal Centers for Medicaid/Medicare Services' Settings Final Rule. The intent of the Settings Final Rule is to ensure individuals receiving services through Medicaid's Home and Community Based Services (i.e. waiver services) have full access to the benefits of community living and are able to receive services in the most integrated setting. While no one would argue against the intent of the Settings Final Rule, it does mean providers will have to be very thorough and document when an individual in services requires a restriction on their rights in order to be safe in the community.
