On behalf of COMCARE, recommend to **accept the proposal from TriTech Software Systems, with an initial system cost of \$61,190.00 and a maintenance agreement for four (4) additional years at \$8,725.00 per year for a grand total of \$96,090.00.**

A review committee comprised of Roger Clark, Tracy Lolley and Kathy Wegner-COMCARE and Kimberly Evans-Purchasing reviewed the responses and selected TriTech Software Systems to provide a demonstration of their solution. EMS staff also attended the demo and reviewed the proposal responses. It was unanimously agreed by all members of the review committee that TriTech Software Systems met all the requirements of the RFP and offered the best overall solution.
