

**RESOLUTION NO. 105-2017**

**A RESOLUTION REGARDING SEDGWICK COUNTY BOARD OF COUNTY COMMISSIONER MEETINGS; DAY AND TIME; PROVISIONS FOR SPECIAL MEETINGS**

WHEREAS, the Sedgwick County Board of County Commissioners previously established the day and time for meeting and provided for special meetings under Sedgwick County Charter Resolution Number 4; and

WHEREAS, the Governor of the State of Kansas has signed House Bill 2102 modifying K.S.A. K.S.A. 19-206 effective July 1, 2017; and

WHEREAS, the provisions of K.S.A. 19-206 on July 1, 2017, will be uniform to all counties in Kansas, nullifying Sedgwick County Charter Resolution Number 4; and

WHEREAS, the Sedgwick County Board of County Commissioners must establish by resolution the days and time each month it will meet for regular session, consistent with K.S.A. 19-206 effective July 1, 2017.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

1. The Sedgwick County Board of County Commissioners shall meet in regular session at the county seat (Wichita, Kansas) each Wednesday at 9:00 A.M. unless said meeting shall be cancelled by the Chairman of the Board of County Commissioners, and in special session on the call of the Chairman for the transaction of any business at the request of the majority of the members on the board. The nature of the business transacted at any special meeting shall be governed by the matters and things set out in the call of such meeting.
2. This resolution shall take effect July 1, 2017, and be published once in the official newspaper of the County.
