- **Motorcycle:** Personalized plates shall not contain more than 5 letters or numbers or a combination of letter and numbers. Personalized disabled plates shall not contain more than 3 letters or numbers or a combination thereof.
- Dashes and symbols are not acceptable; instead leave a blank space.
- Letters &/or numbers cannot be profane, vulgar, lewd or have an indecent meaning.

INSTRUCTIONS

1. Application for personalized license plates shall be made at your County Treasurer's office.
2. Application must be signed by the applicant and include the appropriate fee. Make check payable to the County Treasurer for your county.
3. Two (2) plates are issued for regular and disabled personalized plates for autos and trucks and are required to display both, one in front and one on rear of the vehicle.
4. One (1) plate is issued for regular and disabled personalized plate for motorcycles and antiques are issued 1 to be displayed on the rear of the vehicle.
5. Application for disabled personalized plate(s) are required to submit the original Disabled Certification signed by a healing arts professional or attach a copy of the current Disabled ID card.
