NOTICE TO BIDDERS

You are hereby instructed to include in your bids the following changes and/or corrections to the Drawings and Specifications for the Re-roofing the Sedgwick County **Evidence Storage Building**.

The additions and/or corrections shall be considered as a part of the Contract Documents as if incorporated therein. Where the following corrections and/or additions vary from the conditions of the Drawings and Specifications, such following changes or additions shall govern.

I. GENERAL CLARIFICATIONS:

- 1.1 Please check the Sedgwick County website for a downloadable addendum information including any addendum-issued drawings and documents.
- 1.2 The bid date, time and location remain unchanged.
- 1.3 Approved Equals

Products or manufacturers approved as "Equals" shall meet all requirements of the plans, specifications, standards of performance and construction as established by the product or manufacturer originally specified.

- a. GAF, EverGuard TOP 60-mil is approved.
- b. Carlisle, Sure-Weld TPO, 60-mil is approved.
- c. Johns Manville, JF TPO, 60-mil is approved.

1.4 Existing Sprayed Roof Insulation.

Remove the existing sprayed on roof insulation. Specification Section 07540, paragraph 2, item b. shall be corrected to note the existing sprayed on insulation shall be removed and the new flute filler insulation laid on the existing metal deck/roofing.

1.5 Skylights.

We believe the skylights (translucent, corrugated roof panels) have been filled in with metal panel in the past.

In the event the skylights were not changed to metal panels in the past, the bid form has been revised to include a Unit Price to cover the total cost to remove the existing fiberglass panel and replace it with new metal panel similar to the existing. The Unit Price will be applied to each occurrence that needs to be changed.

1.6 Vapor Barrier

Specification Section 07540 – TOP Mechanically Fastened Roofing System, paragraph 2.05 – Vapor Barrier can be deleted.

1.7 Low Eave.

- a. The rolled edge, low eaves on this building make for a challenge. It shall be up to the roofing contractor if they want to work with the existing condition or they want to cut off part of the roll. The County is looking for a straight, uniform, fascia that is watertight and does not allow water to be drawn back to the face of the building by capillary action.
- b. As part of the shop drawing phase the roofing contractor shall submit a sketch of their plan to finish and dress this edge to the County's project manager for approval.

1.8 TPO System.

- a. The roof system shall be clarified to have the insulation and cover board mechanically fastened to the existing roof deck. The TPO membrane shall be fully adhered to the cover board per Firestone's recommendations.
- b. The roofing contractor shall provide a fastener pull out test to determine the number of fasteners required. The roofing contractor shall provide mechanical fasteners in sufficient quantities to meet or exceed the minimum required by the roofing manufacture based on the pull out test.

1.9 Fascia.

The metal fascia and flashings shall be a minimum of 24-ga., pre-finished metal. A Kynar bronze finish, actual color to be selected by the Owner from the standard finishes available. The flashings should be shop fabricated.

1.10 Shed Roof.

On the East end of the building there is a lean-to shed. This roof is not included in this project.

1.11 Conex Storage Container.

There is a Conex storage container next to the South side of the building. For bidding purpose it should be considered that this box will remain in place for the duration of this project.

1.12 Broken Area Lights.

Above the existing overhead doors, South side, there are two broken area lights that shall be removed. The conduit that feeds these lights punch through the rolled roof edge. This conduit shall be removed.

1.13 Snow Guards.

Snow guards have not been considered for this project.

- 1.14 Sheet A1.2, Detail 7
 - a. This detail is showing the existing gutter and gutter bracket being removed. The finish of the eave shall be similar to detail 4 and as noted in item 1.7 of this addendum.
 - b. The note that is doubled up says "Continuous Cleat, See Note #5".
- 1.15 Various County agencies have their base of operations in the compound that includes the Evidence Storage building. As such we request that the roofing contractor have their employees park across the street.
