Sedgwick County CIP Project B484 is the replacement of a bridge located on 95th St. S. just east of Broadway. It's a 79 year-old bridge that was partially rehabilitated in 1985. This 2-lane highway corridor carries just under 1,000 vehicle per day, and is one of only two paved routes between Broadway and Hillside south of Haysville. The bridge is structurally deficient with a sufficiency rating of 17.9 out of 100. Public Works placed load restrictions on the bridge in 2015. Last year, lanes were reduced to 10' in width to limit traffic loads on the outer, heavily deteriorated beams.

Tim Myers: Have we had business with Prado Construction LLC in the past?

Jim Weber: I don't believe so. They have met the specifications required to be on the KDOT (Kansas Department of Transportation) list of approved contractors. That's mostly about financials with KDOT and so if it's on KDOT's list, we're okay with it.

Russell Leeds: I see on the note that Conspec, Inc. DBA Kansas Paving, which appears to be the low bid withdrew their bid due to nonjudgmental error. Can you offer an explanation?

Jim Weber: What it looks like that happened is and we did not talk to them. I think Purchasing did talk to them but what we picked up was their price for the concrete looks like it was priced it out by the square foot instead of the square yard. That is a nine times difference in that particular element. The way the specs are set up that's a non-judgmental error since it is just a mistake that's happened you can't change your number but you know we don't want to hold a contractor to their bid if they're going to try to cheat the whole time because they've got to make the money right.

Joe Thomas: I confirmed that by a phone call.

On the recommendation of Josh Lauber, on behalf of various county departments, Russell Leeds moved to establish a contract with McKesson Medical-Surgical, Inc. (McKesson) based on the State of Minnesota Multistate Contracting Alliance for Pharmacy (MMCAP) #171-180000000668, good through March 1, 2020 with options to renew for three (3) additional one (1) year periods. Randy Bargdill seconded the motion. The motion passed unanimously.

These products are used as operational supplies for the daily clinical work done by several Sedgwick County Health Department (SCHD) programs including Immunizations, General Clinic, Women, Infants, & Children (WIC), Disease Investigation Services (DIS), Tuberculosis Control Program Clinic (TB), Children's Dental, and Healthy Babies. SCHD has slowly shifted to using McKesson as its main vendor for expendable medical supplies and equipment over the past several years.

This is due to:

· Consolidation of vendors: McKesson has bought out previous county vendors (PSS World Medical Inc. and Moore Medical).

• Product variation: McKesson has product options that aren't available from other contracted vendors like BoundTree Medical LLC.

• Proximity: McKesson has a local warehouse in the Kansas City area that is able to fulfill orders within 1-2 days of receipt of purchase order (PO).

Note: MMCAP conducted a competitive solicitation process and received thirteen sealed proposals.

Questions and Answers

Russell Leeds: Do we have questions from the Board? Do we have any idea what the annual value of this contract for the county? I realize we're talking about multiple departments and various needs.

Joe Thomas: We don't have that figured, but we can reach out to each of these programs and see if they can provide us with that information.

Kevin Eddy: I'm in the Central Supply we tend to order for most of these programs that were listed. Last year we did invoice total of \$59,546.55 for various supplies and we started using McKesson for more items as others vendors have stopped supplying.

On the recommendation of Josh Lauber, on behalf of Emergency Medical Services, Tim Myers moved to **accept the quote from Stryker Sales Corporation for the contracted rates listed above.** Randy Bargdill seconded the motion. The motion passed unanimously.

The service agreement from Stryker will provide EMS the diagnostics and repairs needed for all Stryker LIFEPAK 15s (monitors and defibrillators) and Lucas Compression Systems (chest compression devices). Many of these repairs must comply with the Food Drug Administration (FDA) guidelines and be performed by an FDA authorized service technician from the manufacturer. Failure to follow these FDA protocols on repairs could place liability on EMS and the county for any potential equipment failures during critical patient care.

EMS currently has 37 of the Stryker LIFEPAK15s in service, deploying one (1) in each ambulance and two (2) in each of EMS supervisors' vehicles. The LIFEPAK 15s are a biphasic monitor/defibrillator that is used in emergency cardiac patient care. The LIFEPAK 15s will allow for 12-Lead EKG acquisition and interpretation, synchronized cardioversion (for treating unstable fast rhythms like <u>supraventricular tachycardia</u> or <u>atrial fibrillation</u>), external pacing (for post-cardiac arrest, bradycardia, and/or <u>heart-block</u> patients), monitor oxygen saturation, CO2 output for intubation, and blood pressure.

EMS also has four (4) of the Lucas Chest Compression Systems, one (1) in each of EMS supervisors' vehicles. The system is used to provide consistent, high quality automated chest compressions (CPR) for extended periods of time during critical cardiac patient care.

This service agreement will provide service and maintenance repairs for all EMS LIFEPAK monitors/defibrillators and chest compression devices. The service agreement will include 24/7 technical support, loaner devices, onsite preventative maintenance inspection/service, battery and support device replacement. It will also provide all FDA reporting on device failures and detailed service reports on all repairs. The agreement also provides discounts on all supporting equipment and any future upgrades needed on all devices.

Questions and Answers

Russell Leeds: Questions from the Board on this item? So we're looking at a three year contract for these, correct? Step to the mike and state your name.

Paul Gibson: Paul Gibson, EMS. That is correct. It is a three year contract paid out in increments over one year payments for three years.

Russell Leeds: Are we currently in an agreement with them for the same type of service?

Paul Gibson: Yes, we're currently in agreement with them now.

Russell Leeds: How long have we had these particular pieces of equipment?

Paul Gibson: LIFEPAK 15s we've had since 2014.

Russell Leeds: Okay, so we've been in an agreement to maintain since '14.

Paul Gibson: Paul Gibson: Correct.

Russell Leeds: And we're renewing for an additional three?

Randy Bargdill: Does each one of these devices receive a regularly scheduled inspection once a year or something?

Paul Gibson: Yes, they all receive a PMA Preventative Maintenance service on all monitors and the Lucas devices once a year. At that time they will make any necessary repairs that may not be seen during another maintenance repair. They'll do updates to software and replace any parts that might be broken on it.

Russell Leeds: Good morning.

Greg Gann: Yes, Telestaff is for Public Safety. It is a scheduling software service that provides 24/7 scheduling integrated with our timekeeping and payroll. The fact that our Public Safety is a 24/7 entity, we require 24/7 support. Our experience with them to date has been satisfactory.

Russell Leeds: It appears that this contract is for less than \$91,000.00. It is anticipated to be \$74,552.83, is that likely to increase for any reason?

Greg Gann: No, I don't see that happening. They've done a very good job of keeping the cost inline. We've asked them to reevaluate and give us their best pricing.
