KANSAS OPEN MEETINGS ACT

- "In recognition of the fact that a representative government is dependent upon an informed electorate, it is declared to be the policy of this state that meetings for the conduct of governmental affairs and the transaction of governmental business be open to the public." K.S.A. 75-4317(a).
- KOMA is interpreted liberally and exceptions construed narrowly to carry out the purpose of the law. Murray v. Palmgren, 231 Kan. 524 (1982).

GROUPS SUBJECT TO KOMA

- Political and taxing subdivisions: cities, counties, townships, school districts, community colleges, watershed districts, rural water districts, drainage districts.
- · State agencies and boards.
- · Subordinate groups (boards, commissions, committees, subcommittees):
 - Public Funding- receiving or expending and supported in whole or in part by public funds
- K.S.A. 75-4318(a)

WHAT IS A MEETING?

K..SA. 75-4317a defines "Meeting" as:

(3) Any gathering or assembly in person or through the use of a telephone or any other medium for interactive communication

(a) By a majority of the membership of any agency or body

A majority is defined as the next whole number greater than one-half the total number of members.

(3) For the purpose of discussing the business or affairs of the body or agency

- Binding action or voting is not necessary discussion of business is all that is needed under KOMA.
 Social gatherings are unlikely to trigger KOMA requirements—unless business is discussed.

MEETINGS- A BROAD CONCEPT

- · "Gathering or assembly" can mean:
- · Meetings by phone, email, Skype, through third parties, etc.
- Informal discussions before or after a "meeting" are subject to the Act.
 - Name or title of the meetings, such as "work session" is irrelevant.
- If all the requirements of KOMA are met it is a covered meeting.

SERIAL MEETINGS

Meetings in a series are covered by KOMA:

- · If they collectively involve a majority of the body, and
- · Share a common topic concerning the business of the body, and
- Are intended by any or all to reach agreement on a matter that requires binding action to be taken by the body.
- K.S.A. 75-4318(f)

ELECTRONIC MEETINGS: Email, texts, chat rooms, and instant messaging

- · Beware of electronic means of communication that could violate the Act.
- Electronic communication can trigger the KOMA requirements.
- · Can also include Facebook and Twitter.
- "Interactive communication" requires a mutual exchange between a majority of members of the body.

NOTICE FOR MEETINGS

- What notice is required?
 - Must establish the date, time, and place of the meeting
 - K.S.A. 75-4318(b)
 - · Notice can be written or oral, but made directly to the person requesting it
 - One-time notice is sufficient for regularly-scheduled meetings
 - Must be given in a reasonable time prior to the meeting

MEETINGS AND AGENDAS

- No requirement for a body to create an agenda
- Unified School District No. 407 v. Fisk, 232 Kan. 820 (1983)
- If an agenda is created, it must be made available to those who request it
 - K.5.A. 75-4318(d)
- Meeting must be open to the public
- KOMA does not dictate the location or accessibility of the meeting; however, the ADA requires the public meeting be
 accessible to persons with disabilities
- Telephone and conference calls are allowed if requirements of KORA are met
- Voting must be conducted openly during the meeting

ENFORCEMENT OF KOMA

- · Attorney General, County or District Attorney may bring the action
- · Court may fine up to \$500 for each violation
- · Fine is personal to the body member
- Violation occurs when person participates in conduct that is prohibited by act
- Other potential legal ramifications may include injunctions, mandamus, court costs, attorney fees, invalidation of action, removal from office
- K.S.A. 75-4320 through 75-4320f
- This does not require specific intent or bad faith: "Ignorance of the law is no excuse." State of Kansas v. Palmgren, 231 Kan. 524 (1982).

KANSAS OPEN RECORDS ACT

- "Public records shall be open for inspection by any person unless otherwise provided, and this act shall be liberally construed and applied to promote such policy." K.S.A. 45-216(a).
- KORA provides the procedure for the public to view and obtain copies of "public records."
- "Public record" means any recorded information, regardless of form, characteristics or location, that is made, maintained or kept by or is in the possession of:
 - (A) Any public agency; or
 - (8) any officer or employee of a public agency pursuant to the officer's or employee's official duties and that is related to the functions, activities, programs
 or operations of any public agency.
 - This would include a wide variety of records, including agendas, minutes, written communications, emails, texts, etc. *
 - K.S.A. 45-217()
- KORA defines and categorizes records. Sedgwick County is subject to KORA.
- Must be acted upon as soon as possible, but not later than the end of the 3rd business day following date the request is received. K.S.A. 45-228(d)

KORA, continued

- Statutory presumption that public records shall be open for inspection by any person unless otherwise provided.
- 55 statutory exceptions under K.S.A. 45-221(a); other statutes apply
- For advisory boards, you should forward any open records requests to the County (KORA Freedom of Information Officer)
- County personnel will handle KORA requests

ENFORCEMENT OF KORA

- Any public agency that knowingly violates any provisions of KORA or intentionally fail to furnish information as required shall be liable for the payment of a civil penalty in an action brought by the attorney general, or county or district attorney in a sum not to exceed \$500 per violation. K.S.A. 45-232
- Concerning KORA and records, the district court of any county in which public records are located shall have jurisdiction to enforce by injunction, mandamus, declaratory judgment or other appropriate order, in an action brought by any person, the attorney general or a county or district attorney. KSA. 45-212
- In investigating alleged KORA violations, the attorney general or county or district attorney may:
 - subpoena witnesses, evidence, records, and etc
 - Examine records or other documentary mater
 - Require attendance
 - Facus interessed and
 - And administer oaths and affirmations
 - K.S.A. 45-228
- a. Question: What records fall under KORA besides minutes?
 - a. Agendas, communications concerning board business (emails, texts, etc.)
 - b. Statute now includes communications from private devices
- b. Question: Do subcommittees of the board fall under KOMA/KORA?
 - a. Yes
- c. Freedom of Information officer: Jennifer Scriven
- d. Should err on the side of caution when it comes to KOMA/KORA
- e. Olivia: wants to ensure that KOMA/KORA is not used as an excuse to not be productive and transparent with members
- f. Need to consider board's bylaws regarding meetings and records as well
- iii. 911 Site Visit Review/Discussion
 - Olivia: Need education for people on what kind of things to call 911 for; ability to text 911 if needed
 - b. John: staffing problems; people working are both dispatchers and call takers
 - c. Joseph: enjoyed the tour and was impressed with the work being done; still struggling to find people to take on roles; thorough training provided to staff
 - d. David: impressive work being done in very small space
 - e. Question: When will Computer Automated Dispatch be operational?
 - a. Was operational as of April 18th
 - f. Graphic on website that shows when to call/not to call 911
 - g. Suggestion for County to implement policy to train people willing to learn another language; provide larger differential for multilingual workers across County
 - h. Diversity is top priority in department; important to have representation
 - a. Andrew: parents are immigrants; saw lack of trust in government due to experience in country of origin
 - b. Olivia: immigrants may not be aware that 911 will serve you regardless of immigration status

8. Discussion Items

- a. Exploration Place \$7 million ask
 - Would like more information regarding private donor money, request to City, etc.
- b. Deficit spending: \$9 million projected shortfall
- c. County purchasing plane to transport inmates
- d. Need for adolescent detox treatment

- e. Faith Martin: also need answer from the County jail regarding how they will segregate spaces after new state law
 - a. Sheriff Easter has previously shared that current policy is to assign people based on their gender assigned at birth; no answer about intersex people not assigned a gender at birth
- f. Faith Martin: people awaiting trial make up huge portion of County jail population
 - a. Juveniles are being tried more often as adults; affects number of beds in Adult Detention Facility
