Welcome and Introductions

Grace called meeting to order.

Review Minutes of Previous Meeting

The minutes dated 02/14/2023 were approved.

1st Q 2023 Quality Assurance Committee outcomes

25/43 individuals reviewed needed service modification plans (SMPs) – 58% (up 6%)  
14/18 providers reviewed were assigned SMPs – 78% (up 7%)  
56 SMPs were assigned out of a possible 791 – 7.1% (no change from the previous quarter)

Choice was discussed by the committee members as there has not been a deficiency within the last year.

One goal per service was identified as a common deficiency in the TCM area.  
Low scores in the PCS Self Directed Service was noted.

Two agencies that were on intervention plans have successfully completed their

intervention.

One agency was found to have ongoing trends related in the quality area regarding PCSP's for Targeted Case Managers.

### Board Discussion

Added an item on the agenda that allows board members to ask questions, provide experiences, or give recommendations to staff

Attendance has been an issue. Board members asked whether the commissioners are aware of lack of attendance by their appointees and questioned whose role it is to inform the commissioners if their representatives are not attending? Tim asked if we held the meeting at a different time would it be helpful? Those in attendance agreed the lunch time works. Grace said she would get with the commissioners and update them on attendance if necessary.

Sherry shared a copy of the CDDO Monthly Report and asked if it would be something the Board would be interested in receiving for their meetings. She also stated the KDADS Statewide Waiting List report can also be provided.

Engagement from affiliates. Option to have them attend meetings. Will check with affiliates at next Affiliate Directors meeting to check their interest in engaging with the Advisory Board and report back.

### Legislative Updates

Funds to increase TCM reimbursement to \$75 per hour.

\$2 million in funds for behavioral health grants for IDD system.

The legislature passed provisional language directing KDADS to conduct an IDD funding study incorporating inflationary indexes for the 2024 Legislative Session.

Proviso language directing KDADS to develop a new IDD community support waiver for the IDD system.

The legislature included \$1.2 million for dentures for Medicaid populations.

## Consolidation Update

July 1, 2023, start of the new fiscal year, the CDDO will be intergrated into a new Department of Aging and Disability Services reporting to Annette Graham. The CDDO will be one of many different organizational units reporting to Annette.

Tim Kaufman requested board members to let him know if they find that the consolidation is impacting services.
