A brush truck is a specialized vehicle used for a quicker response to fires such as car, trash, grass, and other types of fire calls that may not require large amounts of water. This vehicle carries specialized equipment and can be taken off-road for the fighting of grass and wildland fires. The Fire District 1 utilizes several of these apparatuses throughout the county, as well as assist other surrounding counties.

Questions and Answers

Russell Leeds: Just for clarity on this, I see it's a 30 year old vehicle, 1994 model, and just kind of talk about the condition of the vehicle so we can understand.

Brian Richey: Typically we replace them before now. We bid this vehicle last year but the vendor wasn't able to produce the vehicle so we rebid it again this year. When they get this old, getting parts for them can be quite cumbersome. The downtime or the times they are out of service are somewhat longer than they need to be. This truck is way past its useful life.

Russell Leeds: This truck was forecasted in the budget and funded this year since you couldn't last year?

Brian Richey: Correct.

Brandi Baily: So you said we bid this last year and the vendor wasn't able to produce it for us. Are you worried we're not going to get this one?

Brian Richey: I haven't had any of those indications from Ford. Everything we've ordered from Ford in the last year has been delivered. The vendor from last year was from out of state. I think we've had some other issues as well from that same vendor. That's just speaking from hearsay from what I know anyway.
