On the recommendation of Lee Barrier, on behalf of the Division of Information & Technology, Anna Meyerhoff-Cole moved to **utilize 1 Government Procurement Alliance (1GPA) Contract #22-02PV-12 with Logicalis, Inc., good through December 8, 2024 with two (2) one (1) year options to renew.** Jennifer Blasi seconded the motion. The motion passed unanimously.

Sedgwick County is seeking to utilize the 1GPA contract with VAR (Value Added Reseller) Logicalis, Inc. to purchase Pure Storage. This storage is an all-flash storage array. An all-flash storage array offers high performance with faster data access and improved reliability due to its solid-state design. It consumes less power, requires less cooling, and takes up less space than traditional hard drive arrays.

Flash arrays are easily scalable, support modern workloads, and enhance data protection and recovery. Flash storage reduces long-term expenses through energy efficiency and maintenance savings. The result is quicker application response times and a compelling option for optimizing IT infrastructure.

Logicalis, Inc. is a VAR for several Sedgwick County IT software applications.

On the recommendation of Jaimee Witmer, on behalf of Household Hazardous Waste, Tim Myers moved to **accept the proposal from Clean Harbors Environmental Services, Inc. and establish contract pricing at the rates listed above for a period of one (1) year with three (3) one (1) year options to renew.** Anna Meyerhoff-Cole seconded the motion. The motion passed unanimously.

A committee comprised of Susan Erlenwein - Environmental Resources; Cody Corbett and Steven Willis - Household Hazardous Waste; Jerry Martin - Public Works; and Jaimee Witmer - Purchasing evaluated the proposal responses based on the criteria set forth in the RFP. The committee unanimously agreed to accept the proposal from Clean Harbors Environmental Services, Inc.

Sedgwick County has operated a Household Hazardous Waste Program since January of 2002. This facility is located at 801 Stillwell, Wichita, Kansas. The mission of the Household Hazardous Waste Facility is to reuse and recycle as much of the material that enters the facility as possible.

Services performed at the Sedgwick County Household Hazardous Waste Department (SCHHWD) include all site operations, transportation, and disposal services required by a special waste collection program. Operations consist of collection and consolidation of regulated and non-regulated special wastes generated from residents (individual households) and qualified businesses (qualifying conditionally exempt small quantity generators), located in Sedgwick County, Kansas.

Tim Myers: Do you have any experience with Clean Harbors Environmental Services?

Jaimee Witmer: We do. They're actually our current contract holder at the moment. We've been using them, I'm not sure. Susan and Cody, how long have we been using them? Would you say?

Cody Corbett: At this point, I would say probably close to seven (7) or eight (8) years.

Tim Myers: Are we happy with the services they provide?

Cody Corbett: Yes.

Brandi Baily: So looking at this bid, it lists remotes. So this covers doing the remote sites when we go out and about as well. And is that a new option or a new feature?

Cody Corbett: Yes it does cover the remotes as well, the list does. We've been doing the remotes since the facility has been here.

Jaimee Witmer: Those are actually special remote events they set up throughout the year is what that's referring to.

Brandi Baily: Right. I mean I know we do those special events. I just didn't know that those pricings were included in.

Jaimee Witmer: Yes, they are.

On the recommendation of Lee Barrier, on behalf of the Department of Corrections, Anna Meyerhoff-Cole moved to **accept the proposal from Center for Behavioral and Academic Research, Inc. dba McAdams Academy (McAdams Academy) at the amount shown above for a period of one (1) year beginning July 1, 2024 and ending June 30, 2025.** Jennifer Blasi seconded the motion. The motion passed unanimously.

A committee comprised of Lesa Lank, Barrett Ancelet, Beth Hopper, and Larry Burks - Department of Corrections; Heather Liess - USD 259; and Lee Barrier - Purchasing agreed unanimously to accept the proposal from McAdams Academy.

In 2016, Kansas passed the Juvenile Justice Reform Bill, a bill intended to improve the way in which the state works with and assists the youth served by the Juvenile Justice System. As part of this reform, the Evidence-Based Programs Fund was developed to provide for reinvestment in community programs and practices. Research that led to the creation of the bill found that communities lacked evidence-based programs, that services were costly, and that often lengthy waitlists existed.

In keeping with one of the goals of the initial workgroup, to “improve outcomes for youth, families, and communities in Kansas,” this Request for Proposal's Scope of Work requested that agencies or organizations utilize funding from the Evidence-Based Programs Fund through the Kansas Department of Corrections (KDOC) to provide educational instruction and classroom support for juvenile offenders participating in Sedgwick County Department of Corrections Evening Reporting Center.

**Questions and Answers**

Brandi Bailey: So the pricing of this is significantly more than the other respondent. Can you just talk about that a little bit?
