On the recommendation of Britt Rosencutter, on behalf of Public Works, Tim Myers moved to accept the quote from Andale Construction, Inc. in the amount of \$54,179.36. Jennifer Blasi seconded the motion. The motion passed unanimously.

Sedgwick County Public Works is requesting the use of OxCon resurfacing material to correct concrete pavement failures at the openings to the bridge on Central between Webb and Greenwich. The concrete pavement at this location has extensive cracking and has been patched with asphalt in the past, which is a short term fix. The cracked areas will be filled prior to the resurfacing which will be applied over the entirety of the concrete approaches to the bridge resulting in a uniform driving surface.

Andale Construction, Inc. is a known contractor to Public Works and has successfully worked on past county projects.

Andale Construction, Inc. is the only approved contractor authorized and qualified by OxCon Systems to install OxCon Systems Surfacing Products in the Kansas market.

Questions and Answers

Russell Leeds: Lynn, could you just educate me on what ox con resurfacing material is just because you drove all the way down here.

Lynn Packer: I appreciate that. Basically, this is just a fancy way of saying that this is a thin liquid overlay that is made up of some proprietary chemicals in a polymer that is resistant to oil, fuel, de-icing materials, which is what got our attention and is intended to basically cover either asphalt or concrete services. We did a pilot program with this material back two (2) years ago on a small bridge up northeast, and it has done extremely well out there. We have used these types of materials on bridges for many years now. This one's a little bit different, just because they say theirs is not going to wear with de-icing materials and as well as abrasive other chemicals. So we are trying this. This is going to be tried over on Central on the tunnel

that goes underneath the runway at Textron and we have both approaches that are pretty well worn out. Our choice is really to tear it all out and replace the approach, which is expensive and will require a couple of weeks to complete, tear it all and put it back. They say they can basically get this done in two (2) to three (3) days, closing one (1) lane at a time. That's the other thing about this, it cures in less than 24 hours. So it should be an extensive, quite a cost savings if this does work out really well.

Russell Leeds: So extend the life of those repairs where you've had to refill with asphalt over and over, this will extend the life?

Lynn Packer: Because of the permanent repair that we're looking at doing, because it's so far gone out there is really just eradicating it and replacing the concrete surface. For that traffic out there, that's going to be quite an undertaking. We will not be able to do parts of it under traffic like we could with this. So we have to close it down.

Beau Bergeron: Yes. It will save us time and money.

Britt Rosencutter: Based on the Charter, also because they didn't meet specs, and the next lowest bid that met specs is the direction we go on the bid.
