On the recommendation of Britt Rosencutter, on behalf of COMCARE and the Sheriff's Office, Anna Meyerhoff-Cole moved to accept the proposal from David Roberts Consulting, LLC dba Ride Care at the rates listed above and establish contract pricing for one (1) year with four (4) one (1) year options to renew. On the recommendation of Britt Rosencutter, on behalf of Regional Forensic Science Center (RFSC), Jennifer Blasi moved to **accept the quote from Agilent Technologies for a three (3) year total of \$231,897.60.** Anna Meyerhoff-Cole seconded the motion. The motion passed unanimously.

This is a three (3) year renewal agreement with Agilent Technologies for maintenance and support of seven (7) gas chromatograph mass spectrometry (GC-MS) systems that are used in both the Toxicology and Drug Identification Laboratories.

These systems are fundamental for the identification of drugs found in forensic specimens. They are used in testing specimens collected during autopsies (post-mortem biologicals), and criminal cases involving illicit drugs, driving under the influence, drug facilitated sexual assaults, and fire debris (arson).

The laboratory spent \$125,758.94 under the previous three (3) year agreement February 5, 2022 - February 4, 2025.

Questions and Answers

Anna Meyerhoff-Cole: It looks like there's a significant increase in cost from the last contract to this one. Did we add new equipment or what else changed for this increase?

Shelly Steadman: The answer to your question is that our previous agreement was fairly complex. Throughout the course of the previous three (3) year agreement, we did add several instruments and in the third year we did have instruments that went from partial to full year coverage. Additionally, we had traded in some instruments and that were replaced with instruments that had a higher cost for coverage. Finally, this company brought on some annual price increases in 2023 due to economic pressures, and we were somewhat buffered from that because we had a three (3) year lock in price.

I think what we've realized here in our department, because this quote was quite uncomfortable for us and our budget, is that when we lock in these prices for three (3) years, we do not see the incremental 7%, 7%, and 7% year over year price increases. Then when we get to Year 4 and we ask for a requote, we see that 21, 22% price increase. So a combination of adding instrumentation, their 2023 larger percent increase, and that's being buffered from the year over year percent increase is largely responsible for this extra cost.

Russell Leeds: Could you just talk briefly about this as a single source? There are other options for this type of maintenance. Can you just talk about that briefly?

Shelly Steadman: Yes, Agilent is the manufacturer of this instrumentation and they would require that they provide the service and maintenance on these. If we would look for an alternative then we would run into a problem. They would basically refuse to provide that service.

Russell Leeds: Essentially it would void the warranty, so to speak, and they would not touch them again.

Shelly Steadman: That is correct.

On the recommendation of Britt Rosecutter, on behalf of Regional Forensic Science Center (RFSC), Anna Meyerhoff-Cole moved to accept the quote from Thermo Electron North America LLC for a period of one (1) year with two (2) one (1) year options to renew in the amount of \$84,010.97. Jennifer Blasi seconded the motion. The motion passed unanimously.

This equipment is used by the RFSC Toxicology Laboratory for identification and quantification of volatiles (such as ethanol) in biological samples. The instruments are critical for detection of alcohol in DUI cases and the Toxicology Laboratory at the RFSC uses the equipment on nearly every ante mortem and postmortem case that is submitted for testing.

The laboratory previously spent \$17,324.00 per year under a three (3) year agreement January 29, 2022 - January 28, 2025, for a total spend of \$51,972.00. This renewal request is under different terms than the previous service agreement since the laboratory anticipates replacing one (1) of these systems or system components within a three (3) year period.

Questions and Answers

Anna Meyerhoff-Cole: Similar question as last time, just we're seeing another significant increase, not as much as last time. Is this because of the same economic pressures to increase rates or added equipment?

Shelly Steadman: There is no added equipment here. This is going to again be because we had locked in the three (3) year rate last time, so we didn't see the incremental year over year increase. One thing that we ran into with the previous contract is that one piece component was covered with a preventative maintenance only, and so when it needed a repair, we were able to call the company to come and execute that repair. We didn't pay their travel mileage and all the parts and labor, and so we did add coverage for that. These instruments are old.

Another factor that comes into play, I'm guessing with this quote, is that one of these instruments, the last few times they've done the preventative maintenance, when they left that that instrument has not been operational, and they've had a significant amount of additional travel and troubleshooting. So I think we may be seeing the ramifications of that added cost to the company to support that particular instrument and that is why we're trying to replace these. There is additional cost here, as you can see in Year 2 and Year 3, because we are not planning to take a three (3) year agreement. This is a one (1) year agreement with two (2) one (1) year options to renew. So we're paying a little more for that optional renewal instead of agreeing to three (3) years.

Russell Leeds: These are obviously critical pieces of equipment for the work that's being done there. So there really aren't any options other than you need to start replacing some of these old pieces of equipment.

Shelly Steadman: Correct. This equipment is used for pretty much every tox case. This is blood alcohol and every driver and every postmortem specimen is screened for blood alcohol and we're trying to phase these out, and working on validating an instrument, actually, that is currently sitting in the Drug ID lab to accomplish and have some overlapping capabilities here for when this particular instrument is down.

In 2022, the FBI issued a policy that states that any Criminal Justice Information (CJI) "transmitted outside the boundary of the physically secure location" shall be "immediately protected via encryption", meaning radio transmissions that contain CJI have to be encrypted. In response to that policy, the law enforcement agencies of Sedgwick County, under the management of Emergency Communications, applied and received a grant to purchase the necessary software upgrades to encrypt all law enforcement radios within the Sedgwick County system. This purchase is for the software so that programming can commence and the county can be brought into compliance with the FBI policy. This is phase one of a purchase, with the end result being the upgrade of approximately 3,500 radios.

The Motorola Solutions APX portable and mobile radios that are used by Sedgwick County and the agencies and departments within the county can only be flashed using flashes manufactured by Motorola Solutions and are not available elsewhere.

Questions and Answers

Anna Meyerhoff-Cole: We got several responses. Can you kind of explain maybe why we chose Exemplifi just because there is a lot of varying in the prices. I know it's a proposal and not a bid.

Tania Cole: So Exemplifi I believe, gave us the most comprehensive proposal meeting our scope and they had the best experience. We also were able to do a demo with them and were rather impressed with the before and after they could provide for us on their website. Also, I might have Matt weigh in if he can because based on who was on the proposal team, I believe everybody kind of had different things that they were looking for. I was looking for kind of the user ability and the design components. Matt, of course, was looking at kind of the background, the IT architecture background, and then Chantelle Crossman was on there. So what she was really looking for was the ADA accessibility, which Exemplifi, had the best ADA accessibility out of everyone we looked at. So I hope that speaks to that.
