## **Questions and Answers**

Russell Leeds: Will this truck be sold on surplus?

Britt Rosencutter: Yes.

Russell Leeds: Brian, is this the truck that you and your crew use to get around the county and carry materials?

Brian Richey: Yes. It is one of the vehicles that we use. We do use the truck pretty much on a daily basis. A lot of times, if we have a breakdown out in the field or anywhere in the county, this is one of the trucks that we could use to go out in the field, and we carry tools on it, air compressors, a lot of stuff that they can perform the repairs there, instead of having to be in the shop.

Russell Leeds: It looks like it's going to be eight (8) to nine (9) months before Rusty Eck delivers. Currently, are you having maintenance issues with this vehicle? Is it getting old and worn out from driving all over the county?

Brian Richey: It is getting worn out. We're keeping it going as we speak. The reason we did it earlier this year is so we could get it. Typically everybody this time of year, I mean, other municipalities are ordering these type of trucks and the truck schedules are filling out. So if we didn't kind of get in line, I doubt that we could get it in 2025. That's kind of the reason we bid it earlier than we typically do.
