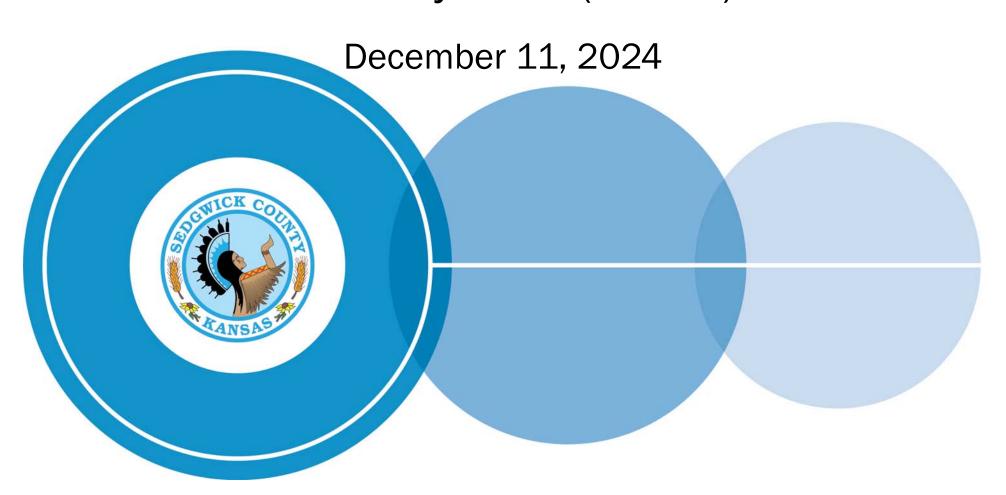
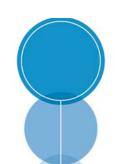

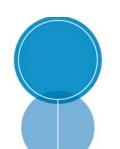




Authorized Uses

- Response to the COVID-19 public health emergency and its negative economic impacts
- Premium pay for essential workers
- The cost of government services, to the extent funding was reduced by the COVID-19 public health emergency
- Investments in water, sewer, and broadband infrastructure
- Certain surface transportation / natural disasters (added in 2023)

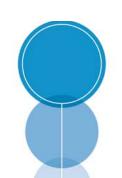

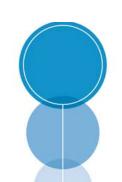

Key Updates Since October

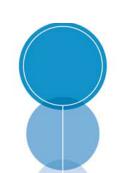
- Change in Presidential Administration lessons learned from CARES. In the SLFRF "Interim Final Rule" issued last November, determination made that future updates would be handled through FAQs. In the midst of CARES, FAQs changed every 11 days on average
- Recommendation is to complete ARPA as of 12/31/24
- What about four projects that were funded past 2024?
 - 1. Ruffin lease (\$1,713,475)
 - 2. Jail locks/cameras CIP (balance of \$10.3 million project not yet paid)
 - 3. District Court contract with BIDS for second chair attorneys (criminal law case backlog) (balance of 2024 bills outstanding, plus \$2,134,503)
 - 4. District contracts with domestic conciliators (family law case backlog) (balance of 2024 bills outstanding, plus \$1,000,000)



Key Updates Since October

Answer: reimbursement of costs to provide government services (aka revenue replacement)

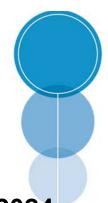
- Based on Treasury calculator, Sedgwick County has "lost" a cumulative total of \$141.8 million from FY 2020-2023
- Year-to-date, SGCO has paid \$37.4 million in direct wages/overtime for the Sheriff's Office in the General Fund, not including taxes or benefits; thus far, \$17.0 million has been reimbursed from ARPA
- This leaves \$20.4 million in GF costs that are able to be reimbursed
- Total expenditures from ARPA are \$83.9 million as of 12/9/24, so up to another \$16.3 million available in ARPA funding



Request of BOCC

- 1. Approve deadlines listed on next slide
- 2. Authorize resolution for immediate interfund transfer of \$10.0 million from Stimulus Fund to GF for revenue replacement
- After final 2024 ARPA costs post by 12/27 at 9 a.m., authorize County Manager to approve balance of ARPA funds to be transferred to GF for revenue replacement – upon execution, notice to BOCC of amount
- 4. Authorize CIP amendment/resolution for interfund transfer from GF to CIP Fund of \$5,938,563.96 for the jail lock/camera project
- Authorize necessary 2025 GF budget actions for District Court and Ruffin contracts and adjustments to 2026 GF base budgets for District Court and Facilities for contracts

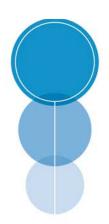
Dec. 14 – last day for ARPA-funded positions to remain in ARPA

Dec. 24 – Final PO adjustments made AND confirmations against POs

Dec. 26 – All 2024 procurement/payment work completed/check run

Dec. 27 - County Manager approves additional transfer of balance of ARPA funds; necessary budget/accounting transactions made to fully spend ARPA; CFO to provide notice to BOCC upon execution
