- During the month of June Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 13 day and 18 residential program visits.
- In June, the SCDDO participated as part of the Sedgwick County Department of Aging & Disabilities in a
 cybersecurity tabletop exercise. Sedgwick County Information Technology Services walked the department
 through a cybersecurity scenario to identify gaps and vulnerabilities and how we can respond to avoid service
 interruptions.
- A new residential provider, MedLife, was added to the Sedgwick County IDD provider network. MedLife is currently working through the managed care credentialing process and should open for service in the new few weeks.
- Annette Graham, SCDDO Executive Director, attended the United Minds Mental Health and IDD Summit in Omaha on June 27th. The Summit hosted a strategic discussion around innovative ideas to address the workforce crisis in the HHS Region 7 (Iowa, Kansas, Missouri and Nebraska). Additionally, workgroups examined topics impacting individuals with dual mental health and IDD diagnosis. Topics included: assessment, treatment and intervention, crisis intervention and system resource issues.
