- During the month of October Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 3 day and 18 residential program visits.
- On October 29<sup>th</sup> the SCDDO hosted a meeting for local civic leaders to learn about the gap in services for individuals with IDD and co-occurring mental health diagnoses and the START model. Staff from the National Center for START Services (NCSS) featured local data on the costs to our community for not adequately addressing this gap in services and how START services could reduce these costs.
- Deputy SCDDO Director, Jeannette Livingston was selected to serve on the Kansas Department for Aging and
  Disability Services (KDADS) Targeted Case Management (TCM)/ Community Developmental Disability
  Organization (CDDO) Conflict of Interest Workgroup. The Center for Medicare/Medicaid Services has required a
  corrective action plan from KDADS to address perceived conflict of interest with agencies that provide TCM and
  other HCBS services and with CDDO's that also provide HCBS services. The Committee has been tasked with
  helping to develop grants to expand system capacity and assist conflicted agencies address the conflict of
  interest.
- On October 30<sup>th</sup>, the SCDDO partnered with AbilityPoint and What's Next Employment Services for a panel discussion on disability employment at a Wichita Chamber of Commerce luncheon. In addition to Jeannette

Livingston with the SCDDO and Jason Crippen with What's Next, the panel included representation from Cintas, Johnson's Landscaping and Goodwill Industries of Kansas. Kristen Marten, a Project SEARCH graduate and current employee for Cintas, also presented as part of the panel.

Andrew Smidt with Northwestern Mutual presented on special needs financial planning at the October meeting
of the Sedgwick County Developmental Disability Community Council.
