- During the month of December Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 20 residential program visits.
- A new residential provider was added to the Sedgwick County intellectual/developmental disability (IDD) affiliate network. Mosaic is a national nonprofit organization that serves individuals with IDD. They are affiliated to provide residential through shared living. Shared living, also known as host homes or sometimes as adult foster care, is where a person or family provides residential supports to someone in their home. Currently there are two other providers in Sedgwick County that offer shared living, GoodLife and ResCare.
- A new medical alert rental company was also added to the affiliate network in December. LifeStation is a national company out of New York. The company has been providing these types of services for over 20 years.
- The Department of Aging & Disabilities kicked off a collaborative Dementia Friendly Sedgwick County project Dec. 3<sup>rd</sup>. At this meeting key stakeholders discussed dementia and the implications for our community. The project is designed to ensure people with dementia and their caregivers feel understood, respected, supported and confident about continuing to participate fully in their community.

- The SCDDO hosted the Sedgwick County Affiliate Directors Meeting Thursday December 12<sup>th</sup>. At this meeting, affiliates provided feedback on the proposed changes to the IDD waiver. These proposed changes include:
  - Switching from the BASIS to MFEI-IDD assessment tool which would include restructuring payments to agencies (going from five tiers to three tiers with a capped complex needs rate).
  - o Unbundling of Day Supports which breaks the current service into seven separate service types which are not necessarily similar to what is currently being provided for Day.
  - Reformation of the extraordinary funding process designed to ensure costs are covered for individuals that need supports over and above what the current Medicaid rate covers.
  - Resolution of the conflict of interest with case managers working for agencies that also provide HCBS services.
